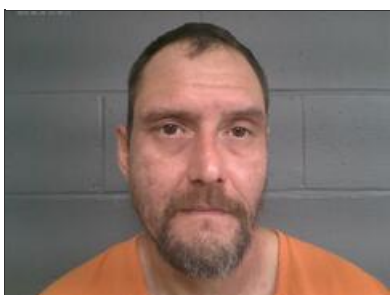

ANY PERSON VIOLATING THIS SUBSECTION SHALL, UPON CONVICTION, BE GUILTY OF A MISDEMEANOR AND SHALL BE PUNISHED AS PROCIDED FOR IN SECTION 17-101 OF THIS TITLE

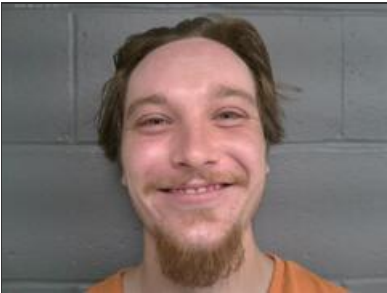

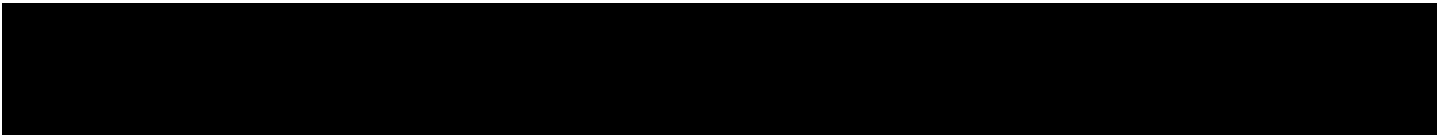

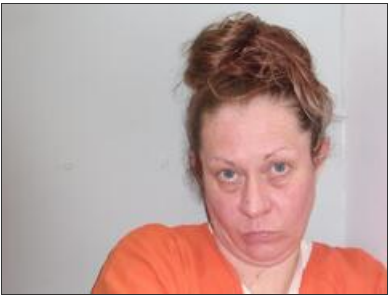
