EVERY LICENSEE SHALL HAVE HIS OR HER DRIVER LICENSE IN HIS OR HER IMMEDIATE POSSESSION AT ALL TIMES WHEN OPERATING A MOTOR VEHICLE. UPON DEMAND OF A PEACE OFFICER, THE LICENSEE SHALL PRODUCE AND PROVIDE PHYSICAL POSSESSION OF THE DRIVER LICENSE TO THE PEACE OFFICER. ANY PERSON VIOLATING THIS SUBSECTION SHALL, UPON CONVICTION, BE GUILTY OF A MISDEMEANOR AND SHALL BE PUNISHED AS PROCIDED FOR IN SECTION 17-101 OF THIS TITLE

FAILURE TO REGISTER VEHICLE WITHIN 30 DAYS FROM DATE OF PURCHASE

FALSELY PERSONATES ANOTHER AND IN THE ASSUMED CHARACTER BECOMES BAIL OR SURETY FOR ANY PARTY, IN ANY PROCEEDING WHATEVER, BEFORE ANY COURT OR OFFICER AUTHORIZED TO TAKE SUCH BAIL OR SURETY


