FUND AN INMATE'S ACCOUNT

You may place money on the books for an inmate by sending a money order via the mail. You may bring cash or use a credit card at the lobby of the Jail and place it on a kiosk. You may use a credit card on the website <https://team3.inmatecanteen.com/>.

COMMISSARY

Inmates may order commissary twice per week. Commissary includes items such as food, candy, chips, pop, hygiene, as well as stationary.

TELEPHONES

The telephone system used the Whitman County Jail is C-Tel. You can set up an account at <http://www.ctel.us> which will allow an inmate to make phone calls to your phone.

INMATE HANDBOOK/MANUAL

[Download a copy of the inmate manual.](#) The inmate handbook or inmate manual is a collection of information to assist inmates in understanding the rules of the facility, their rights, their responsibilities, and general information about day-to-day routine at the jail.

WORK RELEASE APPLICATION PACKET

[Apply for work release.](#) To participate in the work release program, you must be on the inmate roster, be eligible to be released, and have a job offer.

Any inmate seeking to participate in school release, work release, or community service while in jail must complete the Work Release Application Packet. Be sure to spend enough time to **completely and accurately** fill out the application. Incomplete applications or attempts to not disclose information requested by the packet may delay your acceptance into the program. All applicants must complete the [Work Release Application Packet](#). If you have a paying job then you must include the [Employment Supplement](#). If you will be driving or getting a ride to a paying job then you must complete the [Transportation Supplement](#).

PERMISSIBLE POSSESSIONS

Wondering what items you may bring to an inmate in the jail? Here is a list:

- Three pair of plain white briefs-style underwear and plain white tee-shirts, women may have three white bras (without underwire).
- Three pair of white socks.
- One set of white long johns (thermal underwear).
- Clothing items must not have zippers, buttons, nor strings.
- A total of three reading items (books, magazines). Legal books and school books, with Officer approval, are extra.
- Up to four pencils and one set of colored pencils (24 or less).
- A reasonable amount of stationary, envelopes, and stamps.
- Art paper in limited quantities.
- A notebook without a metal binder.

Anything not on the above list may not be brought or sent by family. Please note:

- Basic hygiene items are provided and/or are available to inmates.
- Feminine hygiene articles are available in their unit free of charge.
- Marking pens, ink pens, mechanical pencil, extra pencils, and extra colored pencils are contraband.
